1. *Trustee Report – No report*

2. *Park District Liaison Report* – Park District Liaison McDonald reports the Park District is kicking off its summer staffing. We are looking to hire park district maintenance workers, camp counselors, life guard and various other summer positions. The upcoming Spring/Summer brochure will be coming out next month. Scholarships for 2023 are now open to Glen Ellyn residents. There will be a preschool open house at the end of the month and on February 4. Frozen Fest at Polar Plaza is this weekend 10:00-12:00. The skate park has been replaced at Newton Park. Today we had held our free donuts and bingo. We had about 40 participants. We will continue to offer this event monthly on the third Thursday of every month beginning at 10:30.

Library Liaison Bussey adds perhaps we can frame this as “Tips for Implementing/Starting the DEI Journey”. There would be a number of tips on how to start the DEI journey. Staff Liaison Paplauskas states or we can call the document “Social Sensitivity Tips”.

The CRC discusses next steps for the document. The commissioners ask for more time to review the document. Commissioner Roman-Garcia will send the document over in a google doc so each commissioner can review and provide their feedback and comments. The CRC thanks Commissioner Roman-Garcia for all her work on the draft document.
